Comments: Back in the 1990s, in addition to donating blood, I did volunteer work for the blood center. At this time it wasn't called the BloodSource but instead the Sacramento Blood Center. The volunteer work I did was helping out during the mobile blood drives and I also was a volunteer who telephone/solicited other blood donors. I did this by taking computer print outs, determining who was eligible to donate blood again and calling them at home to ask if they were willing to make another donation. I was good at doing both types of volunteer work for the blood center. At this time my dad was hospitalized and he eventually died. With his death and other things happening in my life, I discontinued my volunteer work. In 2001, The BloodSource added a new paid position for employment and this new paid position was telephone/soliciting donors who were eligible to donate blood. The same position I had done for the Blood Center as a volunteer years earlier. Knowing I was qualified to do this job, I applied for the position. I was contacted by the BloodSource to let me know that I was to attend an interview for the position. When I arrived for the job interview I found myself in a room with about 12 to 15 other women, in which all of whom were also applying for this paid position. The job interview was being conducted by two women employees of the BloodSource. When each of us job applicants gave a short background of ourselves, I realized that I was the only applicant who had done this same job as a volunteer and even mentioned it while sharing about myself. I am not even sure if any of the other applicants had even donated blood. Sometime after this job interview I found out that one of the other women applicants was given the job. Only one of the job applicants applying for this paid position had done this same job as a volunteer. It appeared to me that the BloodSource thought I was qualified to do this job as a volunteer but wasn't qualified to be paid for this job. A job that I was good at doing as a volunteer. Or maybe the two Human Resource women, employed by The BloodSource, thought they should hire a woman, while in her past, was never interested in doing this job as a volunteer. These two BloodSource employees, doing the job interview, probably weren't even employees when I was doing volunteer work for the Sacramento Blood Center, I have always enjoyed donating blood for the needs of others. By the end of this year I will have reached the ten gallon mark. Thanks for reading, I just felt it was time for me to share this experience with somebody at the BloodSource.
