Tuition, Before School, and After School Care fees are paid in ten (10) equal installments due on the first day of each month, with the first payment due on August 1<sup>st</sup> and the last due on May 1<sup>st</sup>. All fees not paid by the 10<sup>th</sup> of each month incur a late payment fee.

**Non-Refundable Registration Fee (\$100) and School Supply Fee (\$175) per child due with Registration Form (current school parents have until April 1<sup>st</sup> to pay the school supply fee)**

Good Shepherd must have a **Food Allergy Emergency Plan**, prepared by the child's health care professional on file if your child has been diagnosed with a food allergy. This plan must include the food your child is allergic to, possible symptoms if exposed to the food, the steps to take if an allergic reaction occurs, Both the parents and the health care professional must sign this form. Your health care professional can supply this form.
